Clear nbn™ Copper 120GB 100/40

Information About the Service

Description

The nbn™ Fibre to the Node (nbn™ FttN) service is a residential grade broadband internet service where the existing copper network is used to make the final part of the nbn™ network connection, from a nearby FttN cabinet or micro-node to your premises. It offers a **Peak Information Rate** of up to **100mbps down and 40mbps up**.

Requirements, Availability and Limitations

The nbn™ FttN Service is only available to those who are in the nbn™ FttN area. ([Check our website](#) for coverage at your address.)

Peak speeds refer to the speed delivered to the VDSL2 technology installed at the customer's premises. They are not necessarily equivalent to the speeds you will achieve in practice. Actual speeds will be affected by many external factors which include the number of end-users using the service at the same time, the hardware, software, the connection within the premises (e.g. a wireless router may not operate at the speed of your VDSL2 connection) and the type/source of content being downloaded.

Your data usage is counted in both directions, so if you download 10GB and upload 5GB then your total is counted as 15GB. Your **Data Allowance** can only be used at any time. If you exceed your Data Allowance, your **Peak Information Rate** will be reduced to **128/128kbps** for the remainder of your billing period. If you then continue to download data, your **Peak Information Rate** will be progressively reduced. There is no **Excess Usage** charge.

Equipment Needs

You will require a VDSL2 modem, installed for free at your premises by an nbn™ installer as part of its network rollout. nbn™ retains ownership of the FttN equipment and will service and maintain it. You may also need a router if you wish to use multiple devices at once on your nbn™ FttN service. If you do not already own one, Clear Networks can sell you a suitable device at an additional cost. You are advised to choose a router from our list of hardware options.

Minimum Term

This nbn™ FttN plan option features a minimum 1 month agreement. (Also available with month minimum terms.) A 12 or 24 month agreement gives access to discounted hardware and lower activation fees.

Bundling

This service is not conditional on having a phone line with us. If you choose to purchase a **ClearTalk** service, your broadband service will be discounted by \$10 a month.

Information About Pricing

Installation Fee

Your installation fee on a month-to-month agreement is \$141.90. A once-off \$300 nbn **New Development Fee** is charged if your premises is identified by nbn as being within a new development area without any nbn equipment installed.

Monthly Charges

The Clear nbn™ Copper 120GB 100/40 Month-to-Month plan has a:

- Monthly Charge of \$104.95
- Unit cost of \$inf per 1GB of data
- Peak Speed of 100mbps down/40mbps up
- Peak Data of 0GB and Off-Peak Data of 0GB

Total Minimum Price

On a month-to-month agreement the **Total Minimum Price** is \$246.85, comprising the \$141.90 installation fee and 1 month at \$104.95 per month.

Excess Usage

Both upload and download count towards your monthly included data. There are no excess usage charges, instead traffic beyond the included data quota will be slowed to **128kbps/128kbps**. You can purchase data blocks to remove your shaping. Prices and options are available on our website. It may take up to an hour for your speed to return to normal.

Early Termination Charge

If you cancel your service prior to the end of your contract term you will incur early termination charges. These are calculated by multiplying the number of outstanding contract months times the minimum monthly contract charge.
